What is APQP?

APQP is a structured process that includes critical tasks from concept approval through production. The aim is to create a product quality plan for developing and manufacturing products that meet customer requirements.

APQP is a set of standard procedures that documents the ability to produce a capable part with a reliable and repeatable process through a mutual understanding of the requirements and thorough risk assessment.

APQP is part of the five Core Tools (IATF 16949-compliant) for effective quality management with PPAP, FMEA, MSA, and SPC being the other core tools.

- Process for Product Quality Planning.
- Planning and Defining the Program.

- Product and Process Design and Development.
- Process and Product Validation.

- Purpose of APQP and the relationship among APQP Deliverables like FMEA, Control Plan etc.
