# **Appendix B**Survey Process, Timelines and Participation Fee

## **Survey Process**

- **Step 1**: On receiving confirmation from ACMA members for participation for the survey, Deloitte India will prepare the detailed plan for data collection based on availability of concerned personnel from the member organization.
- **Step 2:** Deloitte (in collaboration with ACMA) will conduct Data Collection and Job Matching Workshops with the member companies either virtually or physically in Delhi, Mumbai, Pune, Chennai & Bangalore in ACMA office/Deloitte office/one of member companies' office to familiarize companies with the process, scope of survey etc.
