I am directed to refer to this Ministry's letter of even number dated 15th November, 2018 (copy enclosed) and to say that the CNG / LPG kit models uploaded by CNG / LPG kit manufacturer on the CNG VAHAN Sewa shall be approved by the testing agencies issuing the certificate of compliance as per rule mandated under the Central Motor Vehicles Rules, 1989.

2. A facility is provided in "CNG VAHAN Sewa" where the CNG/LPG retrofit kit manufacturer upload the inventory against type approved models which is then used for integration with the vehicle details already available in VAHAN when retrofitted. It is requested that this module i.e, "CNG VAHAN Sewa" be used making entries of such retro fitment of CNG/LPG kits against the already registered vehicles to ensure safety and compliance of standards as mandated under rule 115 of the Central Motor Vehicle Rules, 1989.
