INTRODUCTION

Second wave of COVID-19 has spread almost across the country and is causing extensive disruption and placing huge pressure on available medical infrastructure. Lack of Liquid Medical Oxygen, ICU Beds, Ventilators, Medicines, etc. has made the situation worst resulting in tremendous suffering to patients. - 3. Dedicated Staff including Doctors, Nurses and other Support Staff
- 4. 24X7 Water, Electricity, Airconditioning & Power Back-Up Support
- 5. Stocked with sufficient quantity of required Medicines
- 6. Other necessary equipments, furniture and fixtures for effective operation of the Centre
- 7. Arrangements for round the clock Fumigation, Sanitisation & Housekeeping
