During this challenging time of slow-down across the industries, it would be the most opportune time to utilize the excess time and resources to upgrade the skills of our work-force & develop them with out-of-box thinking, motivating, cross-learning through participating at various trainings/competition.

ACMA NR continues to organize the <u>2<sup>nd</sup> 5S Competition 2019</u> in Northern Region to provide an ideal platform for the **Northern Region** based companies to showcase their best practices as also for a cross-learning opportunity from the best implemented practices.

## About 5S

As you are already aware, 5S is a workplace organization method that uses a list of five Japanese Gemba practices, viz.: Seiri, Seiton, Seiso, Seiketsu, and Shitsuke. These have been translated as "Sort", "Set-In-Order", "Shine", "Standardize" and "Sustain".

It is a philosophy and a way of organizing and managing the work place and work flow for continuously improvising the efficiency by eliminating waste.

The Indian Auto Component Industry has already adopted this practice in their respective area resulting in improvement in the eco-system.

This practice makes a great impact on the workforce which significantly motivate, promotes a sense of pride in their work and enhanced ownership of their responsibilities eventually making an organization profitable and competitive.

Companies are advised to follow the appended process:

The "Second ever 5S Competition" of ACMA (NR) will be monitored in 3 Phases viz:

**Phase I** – Confirmation & Submission of Reply form.

Phase II - Awareness Session & Audit

Phase III – Finale

## **PHASE -I**: Confirmation & Reply form with complete details

# PHASE -II: Awareness Session & Auditor's Site Visit

1) Awareness Session for Participating Companies
2) 5S Audit
3) Participating Companies need to bear the following expenses of the Visiting Auditor to their companies:
a) Auditor's travel expenses (by road, train or air, whichever is applicable).
b) Local conveyance and Boarding & Lodging (wherever required).
4) Documents required during Audit:
a) A Pre-filled ACMA's Self-Assessment Audit sheet needs to be submitted to the Visiting Auditor.
b) 5S Manual* <b>optional</b>
c) Cleaning Checklists (Machine/Shop floor/Office/Toilet/ Utilities/ DG area/ETP etc.)
d) Audit Checklists
e) Red Tagging Procedures/ Abnormality Mapping.
f) Waste Disposal Policy
g) Document Retention Procedures ready for examination.
5) Check Points:
a) Facilitate the Auditors to meet the factory manager or Head of the Unit to understand the role, commitment and knowledge of Top Management in 5S implementation.
b) The audit will cover all areas/zones of the factory & presence of respective area in- charge is mandatory during the Audit.
c) Auditors may also interact with the employees informally and make an assessment on their knowledge and involvement in the <b>5S</b> activities.
d) In the closing meeting, a general feedback on the 5S audit will be given.
6) Please do not ask any assessment feedback or the scores with the auditor.

# <u>PHASE –III:</u> Finale

1)	On completion of Phase II, the Companies selected for Phase III (based on the evaluation during
	the Site Visit), will be intimated by ACMA for their further participation & Presentation by their
	team members at the Competition & Finale.
2)	Number of participants attending the Workshop & Final Presentation will be restricted to 2
	persons per company.
3)	The Presentation could be made either in English or in Hindi. However, the Power Point
	Presentation should be in English in the template provided by ACMA with high resolution
	photographs as prescribed.
4)	The Participating Teams would be given 15 minutes and hence the Presentation should be for 15
	minutes only by the companies followed by a 3 minutes Q&A by the Jury team.
5)	Results will be announced on the same day of the Finale in the evening after the Presentations
,	by all the participating companies are over.
6)	The decision of ACMA & the Jury in selection of Winners will be final.

# The Criteria to participate in this Competition are:

- 1) Only ACMA Member companies who have their manufacturing units / facilities in Northern Region will only be eligible to participate.
- 2) The Company should have paid their Membership Subscription for the FY 2019-20 to the Association as also any participation fee for the Events organized by ACMA.

#### \* The presentation by winners and awards distribution ceremony would be intimated to all the participating company.
